TERMS AND CONDITIONS

The Jenne, Inc. "2022 Summit Club" Promotion (the "Promotion") is open only to companies invited to join the Promotion, who are business entities that are domiciled in the 50 United States and the District of Columbia at the time of entry and are in good financial standing with Jenne, Inc. (the "Sponsor").

- 1. PROMOTION PERIOD.** The Promotion begins at 12:00:01 AM Eastern Time on April 1, 2022 and the Promotion will end at 11:59:59 PM Eastern Time on December 31, 2022 (the "Promotion Period"). For purposes of these Official Rules, a "day" will run from 12:00:01 AM Eastern Time to 11:59:59 PM Eastern Time. The Sponsor's clock is the official time-keeping device for this Promotion.
- 2. PROMOTION OVERVIEW.** The Promotion is open to select Sponsor Partner accounts designated by participating vendors and Sponsor that purchase participating vendors' products from Sponsor during the Promotion Period.
 - (a) Qualifying Purchases.** A delivered purchase of any participating vendors' product or service skus through the Sponsor during the Promotion Period at value, less all discounts and returns, (Net Purchase) will be considered a valid purchase which will be applied to the Partner's Minimum Attainment Goal ("Attainment Goal"). The Sponsor, at its sole discretion, shall have the right to final determination on all qualifying products purchased.
 - (b) Prize Award Promotion Structure.** The Partner must achieve at minimum its assigned company Attainment Goal to be ranked for the Prize Award for the Promotion Period. The Prize Award will be awarded to the Partners who at the end of the Promotion Period rank highest amongst the qualifying spots in the standings, as outlined below, based on highest percentage above goal achieved. Partners must be up to date on all required certifications, by partner level, per participating vendor, if applicable, as of close of business December 31, 2022, to be eligible for the award. If they are not, the award will go to the next Partner in rank order, with qualifying certifications.

Partners can only win in one participating vendor ranking. If a Partner qualifies to win in two or more participating vendor rankings, it is up to the Sponsor's discretion to select the participating vendor ranking that the Partner will qualify to win in. Partners are limited to win one trip package, good for two travelers, in the framework of the Promotion.

- 3. PRIZE AWARD QUALIFICATIONS AND DELIVERY.** The Prize awards will be awarded and will be determined by the Sponsor at Jenne, Inc., 33665 Chester Road, Avon, Ohio 44011. The Prize award will be determined based on the receipt of valid purchase orders within the promotional period, and whether the Partner is in good standing to complete the orders. Notification of prizes will be within fifteen (15) business days after the close of the Promotion.
- (a) Prize Award Delivery:** In order to receive a prize under this promotion, the Partner's account must be current at the time of the award. No prizes will be awarded, and prizes will be forfeited, in the event that the Partner's account is not current at the time of the award. Partner may be subject to and responsible for all applicable taxes. **Partner must provide to the Sponsor a completed W-9 for reporting purposes prior to receiving the prize award.  - (b)** Partner, by participating, releases and agrees to hold harmless Sponsor, Jenne, Inc., and its parent companies, affiliates, subsidiary companies, advertising and promotion agencies and its respective directors, officers, employees, representatives and agents, from any and all liability for any accident, loss, tax liability, injury, death or damage of any kind, arising from Partner's participation in this Promotion or in any Promotion related activity, or resulting from acceptance, possession, use or misuse of any prize, or while traveling to and/or from a location as part of or to obtain or use a prize. Without limiting the foregoing, all prizes are provided "as is" without warranty of any kind, either express or implied, including but not limited to, the implied warranties of merchantability, fitness for a particular purpose, or non-infringement.  - (c)** Sponsor, Jenne, Inc., and its parent companies, affiliates, subsidiary companies, advertising and promotion agencies and contest administrators and its respective directors, officers, employees, representatives and agents are not responsible for any typographical or other error in the printing of the Promotion, administration of the Promotion or in the announcement of the prizes. Sponsor reserves the right to modify the Promotion rules at any time without materially affecting the terms and conditions of the Promotion.

In such event, Sponsor may award prizes in a random drawing from all eligible entries received up to the date of cancellation or suspension.

Sponsor is not responsible for any problems or technical malfunction of any telephone network or telephone lines, computer online systems, servers, or providers, computer equipment, software, failure of any registration, email or entry to be received by Sponsor on account of technical problems, human error or traffic congestion on the Internet or at any website, or any combination thereof, including any injury or damage to a participant's or any other person's computer relating to or resulting from participation in the Promotion or downloading any materials in the Promotion.
- (g) **WARNING: ANY ATTEMPT BY A PARTNER OR ANY OTHER PERSON TO DELIBERATELY DAMAGE ANY SPONSOR WEBSITE OR UNDERMINE THE LEGITIMATE OPERATION OF THE PROMOTION MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES OR OTHER REMEDIES FROM ANY SUCH PERSON(S) TO THE FULLEST EXTENT PERMITTED BY LAW, INCLUDING SEEKING CRIMINAL PROSECUTION.**
